# 1. ACTION RECOMMENDED:

Resolution: Adopting the 2018 East Stanislaus Integrated Regional Water Management Plan Update

# 2. DISCUSSION OF ISSUE:

The recommended action is necessary to receive Integrated Regional Water Management (IRWM) Grants and supports SRWA's strategic plan initiatives. The IRWM Act was enacted by the California Legislature in 2002 with the purpose to encourage local agencies to coordinate and collaboratively manage water resources to improve water quality, quantity, and reliability.

In 2008, the IRWM Planning Act was approved which provided for the development of IRWM Plans. These Plans, subject to periodic updates, are required by the State for eligibility to compete for various water resources grants authorized under Proposition 84 and the current Proposition 1 (Prop 1).

In 2011, having satisfied the State Department of Water Resources (DWR) IRWM Regional Acceptance Process Guidelines, DWR granted regional status to the East Stanislaus IRWM, the first step to be eligible for various State grants under the IRWM Grant Program and other grant funding opportunities. The cities of Ceres, Hughson, Modesto, Turlock and Waterford and Stanislaus County have adopted the 2013 East Stanislaus IRWM Plan.

In August 2016, DWR released the Final 2016 IRWM Grant Program Guidelines, for which all IRWM Plans must adhere to be eligible for Prop 1 Implementation project grants. Also released by DWR was the 2016 Planning Grant Proposal Solicitation Package for the Prop 1 IRWM Planning Grant Funding Program.

Stakeholders and partners prepared the East Stanislaus IRWMP Update in 2017 and 2018 based on the DWR Proposition 1 IRWMP Guidelines. In July 2018, DWR deemed the East Stanislaus IRWM Plan Update complete and in conformance with the 2016 IRWM Guideline Standards. The 2018 updated plan and other related documents are available for review at <u>http://www.eaststanirwm.org/documents/</u>.

Per the Prop 1 Implementation Guidelines, each proponent of a project included in an IRWM Implementation proposal must adopt the IRWM Plan. SRWA applied for an IRWM grant in November 2019 as part of the East Stanislaus IRWM Round 1 Grant Projects. DWR notified SRWA on July 7, 2020 that SRWA had been awarded \$5,800,916 for the Round 1 Prop 1 IRWM Implementation Grant. To remain eligible for this grant, SRWA needs to adopt the East Stanislaus IRWMP.

IN THE MATTER OF ADOPTING THE 2018 EAST STANISLAUS INTEGRATED REGIONAL WATER MANAGEMENT PLAN UPDATE

**RESOLUTION NO. 2020-**

WHEREAS, the Integrated Regional Water Management (IRWM) Act was enacted by the California legislature in 2002 with the purpose to encourage local agencies to coordinate and collaboratively manage water resources to improve water quality, quantity and reliability; and,

WHEREAS, an Integrated Regional Water Management Plan (IRWMP) is a voluntary and comprehensive non-regulatory planning document prepared on a regionwide scale that identifies broadly supported priority water resources projects and programs with multiple benefits; and,

WHEREAS, the benefits of integrated regional water management planning are intended to increase efficiencies and effectiveness of water resources planning, enhance collaboration across agencies and stakeholders, and improve responsiveness to regional needs and priorities; and,

WHEREAS, the adoption of an IRWMP is a prerequisite for any state funding of the water resources projects included in the IRWMP; and,

WHEREAS, the cities of Ceres, Hughson, Modesto, Turlock, and Waterford and County of Stanislaus, signed an agreement to participate in the East Stanislaus Regional Water Management Partnership (East Stanislaus), the regional water management group for the region; and,

WHEREAS, in 2013 East Stanislaus prepared and adopted an Integrated Regional Water Management Plan, which was updated in 2018 (the East Stanislaus IRWMP Update) for the region (which includes the Authority service area) in accordance with the IRWM Act; and, WHEREAS, in July 2018 California Department of Water Resources has deemed the East Stanislaus IRWMP Update compliant with the 2016 Integrated Regional Water Management Plan Guidelines and eligible for future grant funding; and,

WHEREAS, the East Stanislaus IRWMP Update references the Stanislaus County Storm Water Resources Plan (SWRP) prepared by Stanislaus County in cooperation with many of the same partners of the East Stanislaus IRWMP; and,

WHEREAS, the East Stanislaus IRWMP Update will ultimately incorporate the SWRP by reference and, through a future erratum, append the SWRP Executive Summary to the IRWMP Update (which will not require readoption by the East Stanislaus partnership agencies); and,

WHEREAS, the adoption of the East Stanislaus IRWMP Update is exempt from California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines \$15262, \$15306, \$15307, and \$15308 because the plan is a study that identifies potential projects, programs, and policies for possible future actions subject to future adoption and approval and because the plan consists of basic data and information collection that would not result in the disturbance of any environmental resource.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the SRWA Governing Board that it adopts the 2018 East Stanislaus Integrated Regional Water Management Plan Update.
